Truth Centered Transformation - rural church training program
Truth Centered Transformation (TCT) is a discipleship program for churches, which teaches Christians to bring all areas of life into alignment with biblical truth and to serve their communities with loving actions. The goals of the program are to see churches strengthened, communities move out of poverty, and God glorified. When all in-person training was halted in March 2020 because of pandemic mitigation measures, we contacted each of our TCT partners regarding their needs and how we could best support them through this season. Their insights ultimately led us to launch a new program called Churches Stronger (see next section for details). We also conducted some Zoom trainings for Master Trainers, created two video modules, and adapted some materials for radio broadcast. Churches Stronger is a practical Bible-based lessons that are delivered via low-data platforms. We launched the Churches Stronger program in April 2020. Many churches faced serious challenges brought on by COVID-19 and lockdowns. The goals of the program are to (1) offer affordable, accessible discipleship tools to Majority World pastors, (2) bring biblical teaching with practical application to believers daily concerns, and (3) strengthen churches during a time of crisis. Churches Stronger provides teaching on issues identified as most important/timely by our local TCT partners starting with finances, hopelessness, counseling skills, marriage, and how to serve others while social distancing. We finished up the first round of lessons in June and then, at the request of the participants, began a new series of lessons in July with topics including parenting, planning, and healthy relationships. We deliver the lessons via WhatsApp and Messenger because, in many countries, social media data packages are much cheaper than visiting websites. We send the lessons directly to about 3,000 ministry and denomination leaders, who pass it along to more than 50,000 churches (according to their self-reporting). The lessons are being translated into 11 different languages and shared via small groups, Sunday sermons, and even seminary curriculum. From April to September 2020, we created and delivered 23 lessons.

RW continues to share their learning platform at frameworkfortransformation.org where the booklets can be downloaded for free. The site also has articles related to the 7 core principles and summaries of the booklets. The Executive Director conducts skype or in-person meetings with organizations who want to learn more about how to incorporate certain principles into their efforts. Assessment of Local Partner OrganizationsWe perform assessments of each partners alignment with RW core principles, effectiveness in programming, and readiness to share tools with others. As a result of these evaluations, recommendations are made for strengthening programs and organizational systems and strategies.

Wholistic Development CenterWholistic Development Center is a 2-year residential program that prepares students for a vocation, including programs for: electrician, handyman, house-helper, restaurant service, and office administration. The curriculum also focuses on soft skills for the workplace, like honesty/integrity and work ethic. In the 2019/2020 school year, there were 28 students attending WDC. Like nearly all other schools around the world, WDC ended the term early in March 2020 and closed for the rest of the school year due to the COVID-19 lockdown. Thankfully, the entire class was able to return to campus in August.
