

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge these Articles of Incorporation for the purpose of forming a non-profit corporation under and by virtue of the laws of the State of North Carolina.

ARTICLE I

The name of the corporation is Lutheran Services for the Aging Foundation, Inc.

ARTICLE II

The period of duration of the corporation is perpetual.

ARTICLE III

The purposes for which the corporation is organized are:

- (a) To solicit, receive and accept gifts, grants, devises, bequests and contributions of any kind, including, but without limitation, money or property, real and personal, or any interest therein, from any person, firm, trust or corporation to be used exclusively in carrying out and in support of the corporate purposes of Lutheran Services for the Aging, Inc. and any or all of its non-profit subsidiaries, provided however, that no gift, grant, bequest, devise or contribution of any such money or property, or interest therein, will be received or accepted if it is conditioned or limited in such manner as will, in the opinion of the Board of Directors, jeopardize the federal income tax exemption of this organization or of Lutheran Services for the Aging, Inc. and its subsidiaries pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as now in force or afterward amended;

- (b) To develop, implement and promote programs in the areas of public information, public relations, sustained annual giving, planned giving, fund raising, capital campaigns and related efforts for securing financial support on behalf of Lutheran Services for the Aging, Inc. and its non-profit subsidiaries pursuant to the aforesaid provisions of the Internal Revenue Code;
- (c) To hold, administer, invest and dispose of such property, and to make payments or distributions from income or principal, or both, to or for the use of Lutheran Services for the Aging, Inc. and its non-profit subsidiaries pursuant to the aforesaid provisions of the Internal Revenue Code; and
- (d) To engage in any lawful act or activity for which corporations may be organized under Chapter 55A of the North Carolina General Statutes and pursuant to the aforesaid provisions of the Internal Revenue Code.

ARTICLE IV

No part of the net earnings of this corporation shall inure to the benefit of any private individual, except that the corporation may pay reasonable amounts for services rendered or other value received, and no substantial part of the activities of the corporation shall be carrying on of propaganda or otherwise attempting to influence legislation. Notwithstanding anything to the contrary herein contained, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or

the corresponding provision of any future United States Internal Revenue Law).

ARTICLE V

This corporation shall have no members.

ARTICLE VI

This corporation shall be governed by a Board of Directors. The members of the Board of Directors shall be elected by the Board of Trustees of Lutheran Services for the Aging, Inc. (hereinafter the Parent Corporation). Any vacancies on the Board of Directors shall be filled for the unexpired term by designation of the Board of Trustees of the Parent Corporation or by its Executive Committee. The number of members of the Board of Directors, their terms of office, and the method of their election shall be provided for in the bylaws of this corporation as approved by the Parent Corporation.

ARTICLE VII

The address of the initial registered office of the corporation in the County of Rowan and State of North Carolina is 2304 South Main Street, Salisbury, North Carolina 28144; and the name of its initial registered agent at such address is Robert Q. Beard.

ARTICLE VIII
