This database collects details of clients' name, address, demographic information, income data, housing data, and utility vendor information. The program manager checks on a regular basis to see that funding is being distributed to the relevant vendors. Each client may only receive assistance once during a grant year (November 1 through October 31); should two agencies pay for the same client in a grant year then one of the payments is disallowed and the agency must pay for the bill with other than EOC's grant funds.
