THESE CLASSES ARE NOW BEING OFFERED VIRTUALLY. MUSEUM OUTREACH TO MIDDLE SCHOOL STUDENTS IN THE CLASS ROOM IN OUR RUSSELL 4 LEARNING LESSON PLAN.
