PIERCE COUNTY PERSON CENTERED PLANNING (PCP) (FUNDED BY PIERCE COUNTY SCHOOL DISTRICTS) & COMMUNITY GUIDE IS A PROCESS FOCUSED ON CELEBRATING THE GIFTS, TALENTS, AND DREAMS OF A PERSON. USING A PROCESS CALLED MAPPING, FRIENDS, FAMILY, AND THE INDIVIDUAL SHARE IDEAS TO CREATE ACTION STEPS FOR THE INDIVIDUAL TO MOVE CLOSER TO THEIR FUTURE AND A MEANINGFUL LIFE. TRAINING IS PROVIDED TO SCHOOL PROFESSIONALS AND A COHORT MODEL OF PCP FACILITATORS ARE TRAINED AND READY TO ASSIST OFFERING WITH SOLUTIONS FOR TRANSITION HIGH SCHOOL YOUTH WITH DISABILITIES AND THEIR FAMILIES. THE STOMP (SPECIALIZED TRAINING OF MILITARY PARENTS) PROGRAM IS FUNDED BY THE DEPARTMENT OF ARMY AND AIR FORCE, TO PROVIDE VIRTUAL WORKSHOPS ACROSS MULTIPLE DAYS, TWO-DAY IN-PERSON WORKSHOPS AND 90-MINUTE WEBINARS ON PARENTS RIGHTS AND RESPONSIBILITIES IN ACHIEVING SPECIAL EDUCATION SERVICES TO MILITARY FAMILIES AND PROFESSIONAL AT MILITARY INSTALLATIONS IN THE U.S. AND ABROAD TO BE COMPLETED BY 2025. IN THIS FISCAL YEAR A TOTAL OF 12 WEBINARS AND 5 VIRTUAL WORKSHOPS WERE COMPLETED. THE BRANCH - MILITARY PARENT TECHNICAL ASSISTANCE CENTER (MPTAC) THIS PROGRAM IS FUNDED BY THE OFFICE OF SPECIAL EDUCATION PROGRAMS (OSEP) THROUGH THE DEPARTMENT OF EDUCATION TO SUPPORT ALL PARENT CENTERS IN THE US AND ITS TERRITORIES WHO SERVE MILITARY FAMILIES OF CHILDREN AND YOUTH WITH DISABILITIES. THE PURPOSE IS TO BUILD THE CAPACITY OF PARENT CENTERS TO PROVIDE EFFECTIVE SERVICES TO MILITARY FAMILIES OF CHILDREN AND YOUTH WITH DISABILITIES. THIS WAS DONE BY OFFERING (3) LEVELS OF TECHNICAL ASSISTANCE: UNIVERSAL, TARGETED, AND INTENSIVE. OUR PRIMARY VEHICLE FOR UNIVERSAL TA WAS THE BRANCH'S WEBSITE, SUPPORTED BY DISSEMINATION VIA E-NEWSLETTERS AND SOCIAL MEDIA. TARGETED TA: BEGAN AN ONLINE VIRTUAL DISCUSSION GROUP WITH PARENT CENTER DIRECTORS AND STAFF FROM THE TOP 10 MILITARY IMPACTED STATES WHICH GREW TO TOP 12, THEN ALL REGIONS REPRESENTING 21 STATES, 29 PARENT CENTERS, AND FAMILY SERVING PROFESSIONALS FROM NUMEROUS MILITARY INSTALLATIONS. MILITARY-CONNECTED OUTREACH INCLUDED A NATIONAL EXCEPTIONAL FAMILY MEMBER MANAGER TRAINING AND PRESENTATIONS AT THE MILITARY CHILD EDUCATION COALITION'S ANNUAL NATIONAL TRAINING SEMINAR. THE BRANCH WEBSITE EXCEEDED IT'S GOAL THAT 85% OF ALL MATERIALS WOULD BE RATED HIGHLY USEFUL. AN INDEPENDENT PANEL OF PARENT CENTER EXPERTS RATED 99% OF ALL RESOURCES WERE OF HIGH QUALITY, HIGH RELEVANCE, AND HIGH USEFULNESS FOR THEIR WORK WITH MILITARY FAMILIES. FAMILY TO FAMILY HEALTH INFORMATION CENTER (F2FHIC) (FUNDED BY THE DEPARTMENT OF HEALTH AND HUMAN SERVICES SINCE 2005) HELPS FAMILIES OF CHILDREN, YOUTH, AND YOUNG ADULTS THROUGH AGE 25 WITH SPECIAL HEALTH CARE NEEDS (CYSHCN), AND THE PROFESSIONALS WHO SERVE THEM, TO FIND RESOURCES AROUND CARE AND SUPPORT. CHILDREN, YOUTH AND TRANSITIONING YOUNG ADULTS WITH CHRONIC CARE NEEDS EXPERIENCE ISSUES THAT ARE COMPLEX. PARENTS AND CAREGIVERS ARE OFTEN CHALLENGED WITH FINDING THE RESOURCES TO MANAGE HEALTH CARE, HAVE ACCESS TO APPROPRIATE SERVICES, AND UNDERSTAND COMMUNITY SUPPORT NAVIGATION. THE FAMILY-TO-FAMILY HEALTH INFORMATION CENTER IS BASED OFF OF A PEER SUPPORT MODEL; THEY PROVIDE INFORMATION, TRAINING, AND RESOURCES FOR FAMILIES AND YOUNG ADULTS WHO ARE IMPACTED BY CHRONIC HEALTHCARE NEEDS AND DISABILITIES. FAMILY TO FAMILY IS A COLLABORATIVE PARTNER IN A NETWORK OF OTHER FAMILY SUPPORT ORGANIZATIONS AND SYSTEMS PARTNERS SUCH AS DEPARTMENT OF HEALTH (DOH), DEPARTMENT OF CHILDREN, YOUTH, AND FAMILIES (DCYF) AND THE DEPARTMENTS UNDER THEM AS WELL AS OTHERS. THIS PROVIDES CONNECTIONS TO LINKING FAMILIES ACROSS THE STATE WITH RESOURCES AND SUPPORTS WHERE THEY ARE. FAMILY VOICES, THE NATIONAL CENTER FOR FAMILY / PROFESSIONAL PARTNERSHIPS, THROUGH A HRSA GRANT, PROVIDES TECHNICAL ASSISTANCE, TRAINING, AND CONNECTIONS TO THE OTHER FAMILY-TO-FAMILY PARTNERING ORGANIZATIONS ACROSS THE 50 STATES AND US TERRITORIES. FAMILY TO FAMILY DEPARTMENT OF HEALTH (F2F DOH) THIS IS A SUB-RECIPIENT CONTRACT WITH THE WASHINGTON STATE DEPARTMENT OF HEALTH'S TITLE V GRANT WITH THE CHILDREN AND YOUTH WITH SPECIAL HEALTHCARE NEEDS (CYSHCN) DEPARTMENT. THIS CONTRACT WAS CREATED TO PROVIDE CLOSER TIES WITH THE F2FHIC AND THE CYSHCN WORK, TO BUILD CAPACITY FOR THE F2FHIC TO DO THIS WORK, AND TO CREATE STRONGER SHARED WORK WITH THE STATEWIDE PARENT TO PARENT (P2P) NETWORK. THIS WAS ACCOMPLISHED BY SETTING PAVE UP AS THE FISCAL AGENT, THROUGH THE F2FHIC, FOR THE DOH DOLLARS THAT ARE SET ASIDE TO PROMOTE AND SUPPORT FAMILY ENGAGEMENT. THIS IS A YEAR-TO-YEAR CONTRACT THAT INCLUDES MONEY TOWARDS A .5 FTE POSITION AND CAPACITY DOLLARS TO SUPPORT 2 OTHER FAMILY SUPPORT NAVIGATION AND TRIBAL OUTREACH WORK. COIIN (FUNDED BY CHILDREN'S HOSPITAL THROUGH A HRSA BASED 10 STATE GRANT) THIS IS A 4-YEAR GRANT SET UP AS A QUALITY IMPROVEMENT GRANT (QI) AROUND THE IMPROVEMENT OF CARE MANAGEMENT FOR CHILDREN WITH MEDICAL COMPLEXITY. THE WASHINGTON STATE GRANT THROUGH SEATTLE CHILDREN'S AND PAVE FOCUSED ON NICU FAMILIES AS THEY DISCHARGED FROM THE HOSPITAL AND THE YEAR POST DISCHARGE. F2FHIC PROVIDED, THROUGH GRANT FUNDING, JOINT LEADERSHIP WITH SEATTLE CHILDREN'S HOSPITAL PRINCIPAL INVESTIGATOR, TWO PART TIME FAMILY PEER NAVIGATORS, AND MANAGING STIPENDS FOR THE FAMILY PARTICIPANTS. FAMILY YOUTH SYSTEM PARTNERS ROUND TABLE (FYSRPT) (FUNDED BY DSHS/BEHAVIORAL HEALTH SERVICES) IS A STATEWIDE MENTAL HEALTH INITIATIVE THAT BRINGS FAMILIES, YOUTH SYSTEM (MENTAL HEALTH, RECOVERY, JUVENILE JUSTICE, CHILD SERVICES, SCHOOL AND THE DIVISION OF DEVELOPMENTAL DISABILITIES) AND PROVIDERS TOGETHER IN COMMUNITY FORUM MEETINGS. THESE MEETINGS ARE USED TO LOOK AT HOW MENTAL HEALTH SERVICES ARE PROVIDED, HOW EFFECTIVE THEY ARE, AND HOW THE SYSTEM COULD BETTER SUPPORT FAMILIES AND YOUTH. PAVE'S RESPONSIBILITIES WERE AS CONVENERS AND FACILITATORS ACROSS COUNTY BORDERS FOR THE OLYMPIC PENINSULA REGION (3 COUNTIES). SPARK WAS ESTABLISHED TO TEACH PEOPLE WITH DEVELOPMENTAL AND INTELLECTUAL DISABILITIES THE VALUE OF LEADERSHIP WITHIN THEIR COMMUNITIES WHILE ENHANCING THEIR LIVES AND LAUNCHING FUTURE POSSIBILITIES. OPPORTUNITIES INCLUDE: SELF-ADVOCACY GROUPS, TRAININGS, AND WORKSHOPS, "TRAIN THE TRAINER" WORKSHOPS TO FURTHER EXCEL EXISTING KNOWLEDGE AND LEADERSHIP SKILLS, INVOLVEMENT IN COMMUNITY EVENTS, LEARNING ABOUT LOCAL GOVERNMENT; HOW THE EFFECTS IT HAS ON PEOPLE WITH DISABILITIES AND HOW PEOPLE WITH DISABILITIES CAN AFFECT IT, AND FINALLY BECOMING INVOLVED AND INFORMED IN DECISIONS THAT IMPACT THE INDIVIDUAL! START NOW! A LEARNING GROUP FOR PARENTS AND STUDENTS WHO HAVE IEP'S WHO ARE IN MIDDLE SCHOOL. THE PURPOSE OF THE GROUP IS TO HELP FAMILIES, INCLUDING SIBLINGS, BEGIN THINKING AND PLANNING EARLY FOR INDEPENDENCE FOR THEIR STUDENTS WITH DISABILITIES WHO WILL NEED SERVICES AS THEY TRANSITION FROM SCHOOL TO THEIR ADULT LIVES. OVERALL, START NOW! OFFERS TWO CONCURRENT TRACKS - FAMILIES AND YOUTH - THAT IS PERSON-CENTERED, COMMUNITY ORIENTATED, AND FUTURE FOCUSED. THESE INTERACTIVE SESSIONS CAN BE ONLINE, IN-PERSON, AND IN COMBINATION. THESE SESSIONS ARE PROVIDED IN PARTNERSHIP WITH LOCAL AREA SCHOOLS DISTRICT'S SPECIAL SERVICES DEPARTMENTS. THE SESSIONS CULMINATE IN A PARENT NIGHT WITH YOUTH SHARING HIGHLIGHTS FROM THE SESSIONS.
