InspirASIAN distributed \$118,000 in scholarships, including seventy two \$1,000 and twenty three \$2,000 scholarships to 95 graduating high school seniors who have been accepted to accredited universities. Students applied online, submitted their transcripts, sent a letter of recommendation, wrote an essay on a topic we provided, and showed their leadership skills through volunteerism at school and in the community. The \$2,000 scholarships were awarded to the top 22 students through the National Scholarship Program. The next tier of students were sent to the local chapters, who awarded the \$1,000 to the next highest ranking 73 students. InspirASIAN works with local high school counselors to help distribute the InspirASIAN Scholarship information. The program is available to all students regardless of race. We are proud to be able to distribute the scholarships to the students based on their needs and accomplishments. While the majority of our scholarship funds were received as a result of a \$100,397 matching grant from the AT&T Foundation, local InspirASIAN chapters hosted a mixture of events to help raise an additional \$20,141 for the scholarship program listed above. Events include Lunar New Year Dinners, Asian Heritage Month activities, art classes, golf tournaments, silent auctions, and candy, cookbook, tee-shirt and pins sales, and the Employee Giving Campaign.

Despite the Shelter in Place mandate as a result of COVID 19 pandemic, some of the local InspirASIAN chapters hosted virtual events for the benefit of their members. Events include lunch and learns featuring executive speakers, sessions on self development topics, cultural events for Lunar New Year and Mid Autumn Festival. In addition to the fees we charged for the events, we also received \$3,500 from AT&T to help sponsor our teams for a future Dragon Boat Team because all Dragon Boat races were cancelled.
