IN 2016 THE PUBLIC AND SURVEY SYSTEM FOUNDATION INC. ENTERED INTO AN AGREEMENT WITH DENNIS MOULAND TO WRITE A NEW TEXTBOOK ENTITLED "21ST CENTURY RETRACEMENTS IN THE PUBLIC LAND SURVEY SYSTEM". IN 2020 THIS CONTRACT WAS VOIDED BY MUTUAL AGREEMENT. MR. MOULAND AGREED TO REPAY THE PUBLIC LAND SURVEY SYSTEM FOUNDATION THE SUM OF \$8,000, FOR THE ADVANCE PAYMENTS MADE TO HIM. AS OF 12/31/2020 MR. MOULAND HAS REPAID \$2,680 OF THE ADVANCE, W/ THE REMAINING \$5,320 TO REPAID BY 7/2021.
