We have two tree nurseries that distributed a total of 750,000 trees at no or low cost to small scale farmers, schools, churches and government offices. We also provide training in agroforestry to all beneficiaries. All activities take place in the Mara region of Tanzania

We support approximately 150 orphans in two related programs in Tanzania - 1 in Kineshi village and 1 in Musoma town. We provide 22kg of maize and 3.5kg of beans to each foster family each month. We also pay for all school expenses through secondary school and provide tutoring and counselling services to the kids in the program.

When I went to mail in the return on that date, I couldn't find an address to mail the forms to and read that I was now required to e-file the forms. I rushed the forms to my local enrolled agent and asked them to e-file them but, of course, they weren't able to do so at that late date. They sat on them for a couple weeks and told me that the IRS e-file service was shut down for several weeks for updating. A month or more later, the enrolled agent contacted me and said she had questions. She also said it would be easier and cheaper for me to just mail the already completed 990 forms in. I told her I thought they needed to be e-filed and she said no - not necessary. So, several months and several hundred dollars later, I posted our 990 forms for FY 2020. Several months later our return was returned via mail with an instruction that had had to be filed electronically. We are all volunteers and not very adept at financial reporting.
