BEFORE COVID-19 AN AVERAGE OF 50 PARTICIPANTS ATTENDED TWO "DIVE-IN" MOVIES WHERE PARTICIPANTS ARE ABLE TO SWIM, FLOAT WHILE WATCHING A MOVIE AND A COMMUNITY "DRIVE-IN" MOVIE IN DECEMBER WITH APPROXIMATELY 44 FAMILIES ENJOYING A NIGHT OUT SAFELY TOGETHER. PARTICIPANTS HAD TIME TO ENGAGE IN SOCIAL CONVERSATION, MEET NEW PEOPLE, ENJOY DIFFERENT ENRICHING ACTIVITIES. VOLUNTEERS CONTINUED WEEKLY FRIENDLY CALLS AND ASSISTED WITH GROCERY SHOPPING FOR THOSE INTERESTED. REGULAR VIRTUAL WORKOUTS DESIGNED SPECIFICALLY FOR AN OLDER POPULATION WERE ALSO MADE AVAILABLE FOR FREE TO THE ENTIRE COMMUNITY. IN 2020, APPROXIMATELY 12 INDIVIDUALS PARTICIPATED IN ONE OR MORE SESSIONS OF A CANCER SURVIVOR PHYSICAL ACTIVITY PROGRAM CALLED LIVESTRONG AT THE YMCA. PARTICIPANTS MET FOR 6 WEEKS AT THE YMCA PRIOR TO THE COVID CLOSURE AND CONTINUED TO MEET VIA VIRTUAL PROGRAMMING DURING AND POST COVID. LIVESTRONG AT THE YMCA IS A SMALL GROUP PROGRAM DESIGNED FOR ADULT CANCER SURVIVORS. THE PROGRAM IS OFFERED AT NO CHARGE TO ANY CANCER SURVIVOR IN THE COMMUNITY. IN ADDITION TO THE PHYSICAL BENEFITS, THE PROGRAM PROVIDES PARTICIPANTS A SUPPORTIVE ENVIRONMENT AND A FEELING OF COMMUNITY WITH THEIR FELLOW SURVIVORS, YMCA STAFF AND MEMBERS.
