THIS INNOVATIVE PROJECT DIRECTLY COMMUNICATES ACTIONABLE SOCIAL AND BEHAVIORAL SCIENCE RESEARCH TO PARENTS, WITH A FOCUS ON HISPANICS BY LEVERAGING COMMERCIAL ENGLISH AND SPANISH TV NEWS CHANNELS, THE PUBLIC'S PRIMARY SOURCE OF NEWS AND INFORMATION.
