OTHER PROGRAM SERVICES INCLUDE: CENTER FOR DIALOGUE & BUILDING THE EL-HINDI CENTER FOR DIALOGUE HAD TO QUICKLY TRANSFORM THE WAY OF DOING BUSINESS, TO ADAPT TO THE NEW WAY OF LIFE THROUGH THE COVID-19 PANDEMIC. WE ARE NOW ABLE TO DELIVER 100 PERCENT OF OUR PROGRAMS VIRTUALLY. THIS UNINTENDED OUTCOME HAS BUILT OUR CAPACITY TO EXPAND OUR FOOTPRINT GEOGRAPHICALLY. 130 SYRACUSE CITY SCHOOL DISTRICT HIGH SCHOOL STUDENTS PARTICIPATED IN THE SEEDS OF PEACE PROGRAMS IN THEIR SCHOOLS, A PROGRAM SUPPORTED LOCALLY BY INTERFAITH WORKS FOR THE PAST 10 YEARS. THIS REFLECTS THE NUMBER OF STUDENTS WHO WERE ON THE SEEDS OF PEACE ROSTER AS BEING ACTIVE AND PART OF THE HIGH SCHOOL SEEDS OF PEACE CLUBS. 116 ONONDAGA COUNTY YOUTH AND 28 ADULT ALLIES, CONCLUDED THEIR PARTICIPATION IN THE SCHOOL EXCHANGE PROGRAM IN 2020 PRE-COVID. SYRACUSE CITY SCHOOL DISTRICT STUDENTS ARE PAIRED WITH A SUBURBAN OR RURAL SCHOOL DISTRICT TO SHARE FACILITATED DIALOGUE SESSIONS TO BREAK DOWN RACIAL AND ETHNIC STEREOTYPES AND BUILD BRIDGES OF UNDERSTANDING. THE EXCHANGES OCCUR AT THE HIGH SCHOOL AND MIDDLE SCHOOL LEVELS. WE CONDUCTED NINE FOCUS GROUPS COMPRISED OF SYRACUSE UNIVERSITY STUDENTS SOLICITING THEIR PERSPECTIVES ABOUT PUBLIC SAFETY, INCLUDING COVID RISKS, ON AND OFF CAMPUS. COMMENCED AN INTENSIVE EFFORT TO UPGRADE AND REFRAMED OUR POLICE-COMMUNITY DIALOGUES BY ORGANIZING SEVERAL LARGE MEETINGS OF COMMUNITY LEADERS AND PUBLIC SAFETY AND GOVERNMENT OFFICIALS. FORMED A NEW PARTNERSHIP WITH PEACEFUL SCHOOLS TO PROVIDE RACIAL EQUITY STRATEGIC PLANNING FOR SCHOOL DISTRICTS. WE ARE EXCITED TO BEGIN OUR PILOT PROGRAM WITH THE CHARTER SCHOOL FOR APPLIED TECHNOLOGIES IN BUFFALO AND ARE GREATLY ENCOURAGED BY THEIR COMMITMENT TO ADDRESSING RACIAL AND SOCIAL EQUITY IN THEIR SCHOOLS. CONCLUDED OUR TWO-YEAR WORK WITH THE SYRACUSE UNIVERSITY COLLEGE OF ENGINEERING AND COMPUTER SCIENCE, WITH 400 STUDENTS, STAFF, AND FACULTY HAVING PARTICIPATED IN A DIALOGUE PROGRAM. EXPANDED OUR WORK WITH SYRACUSE UNIVERSITY THROUGH A NEW PARTNERSHIP WITH THE OFFICE OF DIVERSITY AND INCLUSION, WHICH SAW AN EXPANSION OF THE DIALOGUE PROCESS BEYOND THE COLLEGE OF ENGINEERING TO THE MAXWELL SCHOOL OF CITIZENSHIP AND PUBLIC AFFAIRS, AS WELL AS SU'S SCHOOL OF ARCHITECTURE AND DAVID B. FALK COLLEGE OF SPORT AND HUMAN DYNAMICS. MORE THAN 40 FACILITATORS WERE TRAINED IN THE FALL OF 2020, AND SIX DIALOGUE CIRCLES WERE CONVENED, WITH ANOTHER NINE DIALOGUES CIRCLES AND THREE FACILITATOR TRAININGS PLANNED IN 2021. IN 2020, THE EL-HINDI CENTER FOR DIALOGUE SERVED AGAIN FOR THE CITY OF SYRACUSE TO FACILITATE A COLUMBUS CIRCLE ACTION COMMITTEE, WITH THE GOAL OF SUBMITTING RECOMMENDATIONS ON THE DEVELOPMENT OF A HERITAGE AND EDUCATION SITE AT THE CURRENT COLUMBUS CIRCLE. THE COMMITTEE'S REPORT DOCUMENTS THE PROCESS AND OUTCOMES OF A TWO-MONTH EXPLORATION BY A DIVERSE GROUP OF COMMUNITY MEMBERS REPRESENTING MULTIPLE OPINIONS ABOUT COLUMBUS CIRCLE ASSEMBLED AT THE BEHEST OF SYRACUSE MAYOR BEN WALSH. ENGAGED HUBER-BREUER IN DIALOGUE AND TRAINING FOR ITS 50-PLUS PERSON STAFF, BASED ON THEIR NEW COMMUNITY COMMITMENT TO DIVERSITY AND INCLUSION, WHICH IS A BOLD NEW STEP FOR THE CONSTRUCTION COMPANY. WORKED WITH OUR SISTER DEPARTMENTS AT INTERFAITH WORKS, SENIOR SERVICES PROGRAM AND THE CENTER FOR NEW AMERICANS, RESPECTIVELY, TO ASSIST WITH RACIAL EQUITY TRAINING FOR THE AGING SERVICES COALITION AND "COMMUNITY CONVERSATIONS," WHICH FOCUSES ON THE REFUGEE AND IMMIGRANT EXPERIENCE. FINDING JOBS AND CONNECTING WITH THE NY DEPARTMENT OF LABOR: DESPITE THE CHALLENGES THE COVID-19 PANDEMIC HAS CREATED FOR EMPLOYMENT, 138 NEW AMERICANS WERE PLACED INTO JOBS DURING 2020. THIS ACCOMPLISHMENT IS ONLY SIX FEWER PLACEMENTS THAN THE YEAR-END TOTAL FOR 2019. ADDITIONALLY, 32 CLIENTS PARTICIPATED IN JOB READINESS CLASSES, AND 45 HOUSEHOLDS RECEIVED HELP WITH THEIR APPLICATIONS FOR UNEMPLOYMENT BENEFITS DUE TO JOB LOSS DURING THE EARLY STAGES OF THE PANDEMIC. DURING 2020, SEVERAL COMPANIES ALSO HIRED EIGHT OR MORE REFUGEE CLIENTS. THE COMPANIES INCLUDED A MYRIAD OF WAREHOUSES, INCLUDING THOSE SPECIALIZING IN COLD STORAGE, ELECTRONICS ASSEMBLY AND FOOD PRODUCTION. THE AVERAGE HOURLY WAGE FOR THOSE JOBS WAS \$12.50. FUNDING RECEIVED FROM THE CITY OF SYRACUSE AND THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT ENABLED 275 CLIENTS TO AVOID HOMELESSNESS AND UTILITY DISRUPTIONS. CLIENTS WERE LINKED WITH ESSENTIAL GOVERNMENT AND PRIVATE PROGRAMS THAT ENABLED THEM STAY SAFE AND WARM IN THEIR OWN HOMES AND AVOID FURTHER COMPLICATIONS RESULTING FROM THE COVID-19 PANDEMIC. THROUGH MATCHING GRANT AND EMPLOYMENT PLACEMENT, 23 INDIVIDUALS WERE PROVIDED ALTERNATIVES TO PUBLIC ASSISTANCE BENEFITS. FOR THE SECOND YEAR, PEBBLE HILL PRESBYTERIAN CHURCH CONTINUED TO PROVIDE SPACE FOR THE MATCH GRANT STORE, WHICH ALLOWS CLIENTS OPTING OUT OF PUBLIC ASSISTANCE BENEFITS TO RECEIVE EXTRA ITEMS AND SUPPLIES TO FURNISH THEIR HOMES. THE CENTER'S INTENSIVE CASE MANAGEMENT PROGRAM DELIVERED SUPPORT TO 40 REFUGEE CLIENTS WHO NEEDED ASSISTANCE WITH NAVIGATING THEIR WAY THROUGH THE AMERICAN MEDICAL AND MENTAL HEALTH SYSTEMS. ADDITIONALLY, THE PROGRAM PROVIDED \$4,000 IN TOPS GIFT CARDS, \$2,000 IN CASH CARDS, BI-WEEKLY GROCERIES, PPE, TRANSPORTATION, AND EMERGENCY HOUSING ASSISTANCE AS PART OF ITS COVID-19 RESPONSE TO VULNERABLE REFUGEES. THE CENTER'S PATH TO CITIZENSHIP PROGRAM PROVIDED CITIZENSHIP PREPARATION CLASSES TO 57 INDIVIDUALS. THE DIGITAL SIGNAGE WAS ON DISPLAY FOR MONTHS IN PROMINENT LOCATIONS IN AND AROUND THE CITY OF SYRACUSE. BUILDING UNITED COMMUNITIES INTEGRATES NEW AMERICANS/REFUGEES WITH ESTABLISHED AMERICAN RELIGIOUS CONGREGATIONS.
