years because some volunteers were nervous to be in private settings However, we did reach out to 600 women that worked online prior to Covid

shut down 4Sarah voted Tara Wood as our outreach director to manage club outreaches into the Georgia strip clubs 4Sarah also voted

Rachael Cain as 4Sarah's Alabama chapter Outreach Director to manage our Alabama/Pensacola strip club outreaches Jesse Banks

another amazing survivor leader was managing our Florida strip club outreaches but unfortunately she passed away in December 2020

Part III-29 4Sarah's assessment house celebrated 2 years since opening in December 2020 We were able to serve a total of 6 women, 3 that were

pregnant and 3 that had children in their custody Due to the housing shortage during covid we were very cautious on transitioning women

While the women stayed in the house they were connected with a care team member, counselor and even participated in horse therapy

Part III-30 4Sarah's care team established an online virtual support group to provide ongoing support during the Covid crisis It was led by our

care team coordinator every Wednesday and we offered an optional virtual meeting on Sunday nights for the women that worked

We have had over 42 women randomly participate in the virtual calls that were led by other survivors of the sex industry

4Sarah's intervention program financially assisted 71 women with basic needs and support services during their transition out of the

sex industry 4Sarah also provided 7 educational scholarships to women that are attending school and transitioning out of the

sex industry

The founder of 4Sarah, Kasey McClure was invited to attend the summit on Human Trafficking at the White House on January 31, 2020

This was a private invitation only event that included anti-trafficking organizations from around the US We were able to meet and hear

US President Trump, Vice President Mike Pence, Ivanka Trump, Attorney General William Barr and many other state officials and members of

congress share about the new executive order and how they are combatting trafficking across the world
