IN 2020, DUE TO THE IMPACTS OF THE COVID-19 PANDEMIC INCLUDING PARK CLOSURES AND PROHIBITIONS ON GATHERING, THE CONSERVANCY'S EFFORTS TO ACTIVATE CIVIC CENTER PARK THROUGH ITS SIGNATURE PROGRAMS WERE LESSENED FROM PREVIOUS YEARS. THE CONSERVANCY'S SUMMER OUTDOOR CAFE, "CIVIC CENTER EATS", CELEBRATED ITS 14TH YEAR IN 2020. DOWNTOWN VISITORS, WORKERS AND RESIDENTS ENJOYED LUNCH FROM LOCAL GOURMET FOOD TRUCKS WHILE HELPING TO SUPPORT CIVIC CENTER'S ONGOING REVITALIZATION. 2020 WAS THE SEVENTH YEAR FOR THE CONSERVANCY'S FREE "CIVIC CENTER MOVES" FITNESS SERIES, PROVIDING FITNESS CLASSES FOR ALL LEVELS, PARTICIPANTS GOT HEALTHIER, AND SO DID CIVIC CENTER PARK. IN 2020, 3RD PARTY EVENTS WERE RECRUITED INTO CIVIC CENTER PARK INCLUDING THE DOWNTOWN OPEN SNOWBOARD EVENT. ADDITIONALLY, THE CONSERVANCY HELPED TO FACILITATE THE RELOCATION OF THE CHRISTKINDL MARKET TO CIVIC CENTER AND LAYERED ON ADDITIONAL HOLIDAY LIGHTING. THIS CONTINUES TO BE AN ANTICIPATED AREA OF GROWTH FOR THE CONSERVANCY.
