Cuba ProgramMost of our programming work for 2020 was part of our Cuba-US Agroecology Network, an initiative whose mission is to connect people, institutions and movements in Cuba and the US to build more ecologically resilient, socially just and economically fair farming systems. We do this by raising awareness about Cubas agroecology advances and challenges, facilitating partnerships and building capacity amongst stakeholders through exchanges, courses, conferences and workshops. In addition, we work to amplify Cuban voices internationally, and to channel resources and opportunities to our counterparts on the island. In 2020 our activities were limited due to the covid-19 pandemic. Nonetheless, we were able to organize several online events and collaborative research initiatives. This includes a 6 part virtual conference series titled Resistance and Resilience: Responses to the Climate Crisis from Cuba and Puerto Rico, and a published paper titled Agroecology, Food and the Climate Crisis: Transition, Adaptation and Building Resilience in Cuba. We also continue to raise awareness and advocate for agroecology and food sovereignty in Cuba by writing a monthly news brief to highlight the food, agriculture and environment news from Cuba.

Form 990, Part III, Line 4b:

The second program area is the Research Initiative for the Sustainable Development of Cuba, a collective of academics and non-governmental organizations from Cuba and abroad interested in engaging in knowledge exchanges on Cubas agricultural sustainability and climate resilience. In 2020 we initiated the 4th year of this initiative and are coordinating the writing of a white paper with contributions from Cuban authors on the topic of sustainable livelihoods and coastal resilience.

Form 990, Part III, Line 4c:

The third program area is a material donation that VCI is coordinating for a Cuban institution the Fundacion Antonio Nunez Jimenez. This donation was made by the Flora Family Foundation and consists of solar panels and other renewable energy items. The goal of this donation is to strengthen the material capacity of this Cuban institution. This is a multiyear donation. VCI secured permissions from the US Dept of Commerce to export these items.

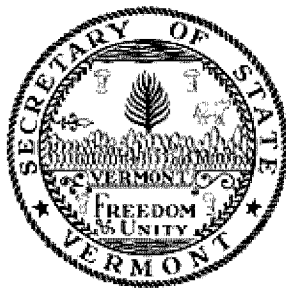
