LEVEL 3 WILL GRADUATE 95 STUDENTS AND LEVEL 1 WILL GRADUATE 377 STUDENTS. THE BREAKDOWN OF THE NUMBER OF STUDENTS IN EACH SCHOOL IS AS FOLLOWS: 78 STUDENTS IN CULINARY ARTS, 154 STUDENTS IN HAIRDRESSING, 34 STUDENTS IN MASONRY, 172 STUDENTS IN SEWING, AND 34 STUDENTS IN WELDING.
