Educational outreach programs continued to flourish including school tours, workshops and art education curriculum for teachers. Exhibits and programming reached a total direct audience of over 10,000 individuals and an indirect audience of over 100,000 who participated in social media or were exposed to murals, radio and TV interviews and media coverage of 516 ARTS. Our 2020 audience mirrored the unique ethnic, socio-economic and cultural mix of New Mexico and we actively reached out to these populations through varied program themes, partnerships with arts and community organizations, targeted marketing, free admission and outreach programs around each exhibition.
