EMBRACE KIDS ADDRESSES THE SPIRITUAL, EMOTIONAL AND FINANCIAL NEEDS OF PATIENT FAMILIES IN THE NEW JERSEY/NEW YORK CITY METROPOLITAN AREA SINCE 1991. EACH YEAR WE PROVIDE APPROXIMATELY \$2 MILLION IN DIRECT AID AND SUPPORT SERVICES TO APPROXIMATELY 200 FAMILIES TO DEAL WITH THE DAILY CHALLENGES THEY FACE.
