ACTION FOR CHIMPANZEES: IN RESPONSE TO REPORTS BY WILDLIFE CENTERS IN WEST AFRICA OF A DIRE INCREASE IN THE NUMBER OF CHIMPANZEES CONFISCATED FROM THE THRIVING ILLEGAL WILDLIFE TRADE, PASA LAUNCHED ACTION FOR CHIMPANZEES TO RESOLVE THIS CRISIS AT ITS ROOTS. THE PROGRAM INCLUDES GENETIC RESEARCH TO SEQUENCE GENOMES OF CHIMPANZEES CONFISCATED FROM TRAFFICKERS AND USE A GENETIC MAP TO DETERMINE THE ORIGIN OF THESE TRAFFICKING VICTIMS, WHICH WILL PROVIDE EVIDENCE OF TRAFFICKING HOTSPOTS AND SMUGGLING ROUTES. THE RESULTS WILL BE USED TO FOCUS ANTI-TRAFFICKING PROJECTS ON PRIORITY AREAS AND AMPLIFY EFFORTS TO STAMP OUT THE ILLEGAL TRADE. ADDITIONAL COMPONENTS OF ACTION FOR CHIMPANZEES INCLUDE A LARGE-SCALE PUBLIC AWARENESS CAMPAIGN ACROSS THE REGION AS WELL AS TRAINING FOR LAW ENFORCEMENT OFFICIALS AND THE JUDICIARY. SUPPLIES FOR RESCUED PRIMATES: PASA SECURES IN-KIND DONATIONS, PARTICULARLY OF MEDICAL EQUIPMENT AND SUPPLIES, FROM A NUMBER OF ORGANIZATIONS. WE ARRANGE FOR THE MATERIALS TO BE TRANSPORTED (TYPICALLY AS TRAVELERS EXTRA BAGGAGE) TO PASA MEMBER WILDLIFE CENTERS IN AFRICA.
