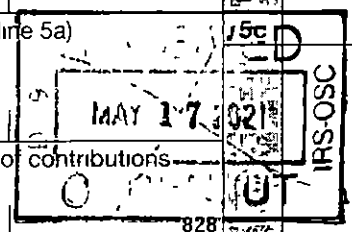

Part III Malawi Matters Inc is a 501(c)3 not-for-profit with a United States based all volunteer board of directors and staff whose mission is to develop and facilitate HIV/AIDS education in partnership with the people of Malawi and Central Africa. In addition, Malawi Matters Inc works to educate Malawian and Central African women for life improvement. In 2020 with the COVID-19 global pandemic restricting travel, Malawi Matters Inc supported the Malawi based Coordinator, regional, area and local representatives to continue the Creative Methods of HIV/AIDS Education work developed by Malawi Matters Inc as well as the Equipping Women/Empowering Girls programs using certified instructors in 200 congregations. Malawi Matters Inc coordinated teaching teams to deliver the program in 1,500 schools. In 2020 the Creative Methods classes, courses and events continued in the various areas and villages covering transmission prevention as well as compassion and care. Topics addressed in the Womens/Girls groups included age characteristics and development, adolescence, menstrual cycle, child marriage, cultural practices, human rights, gender issues, stress management, empowerment and next steps. In addition to the ongoing work in Malawi, U.S. based volunteers disseminated information about Malawi Matters Inc and all the needs in Sub-Saharan Africa by speaking at service Clubs, offering sessions to congregations, leading classes in schools and colleges and conducting programs in libraries. Malawi Matters Inc has continued to provide guidance to the Malawian lead Non-Governmental Organization in the services they are attempting to provide.

Part III, Line 28 - Malawi Matters Inc was incorporated in May 2008 and formed a volunteer Board of Directors in September 2008. The Internal Revenue Service granted Malawi Matter Inc IRC section 501(c)3 status in December 2008. Since then Malawi Matters Inc has continued to work with various Malawian organizations, churches, education districts, local villages and the NGO to provide leadership development, training programs and women services to address the HIV/AIDS crisis. In 2020 with the COVID-19 restrictions on international travel, Malawi Matters Inc adapted its strategy to continue to deliver educational opportunities for the 7.5 million people in its operating area in the central region of Africa.
