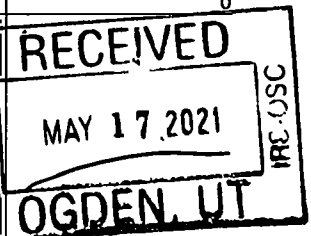

It is at this time that the organization will appoint employees.
