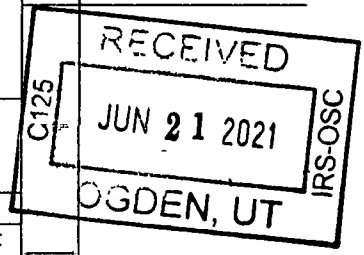

Part Line 10, the figure of 4,650 represents direct donations that LBNF has made to 12 other non-profit ministries important to our organization. The largest include 1,000 to Trinity Life of Hereford, 800 to New Life Restoration Center and three other 500 donations.

Line 16. Other expenses always constitute the bulk of our expenditures for this non-profit ministry. There are unique to our organization as we sponsor evangelists in Africa to travel to indigenous areas to preach the gospel

1 Mission trip expenses, amounting to 75,587 were less than last year probably relective of the Pandemic we faced, limiting our travel internationally. These expenses cover, in this year, ground transportation, 4x4 rental, fuel, rental of evangelism equipment, housing, food and water Other expenses include appreciation to chiefs and officials.

2 Equipment was 13,568 including phones, motorbikes, AV equipment, megaphones, generators and repairing of such items used in the field

3. Other evangelism supplies totalled 5,972.

4 Humanitarian Aid was considerable at 13,321 which included everything from helping the people of Agadez, Niger with their regular disaster relief from flooding/drought (over 4,000), to paying for hospitalizations of our men who suffered at the hands of violent extremists, or even bailing our evangelists who may have been arrested for preaching Jesus, or bailing out new believers at the request of a local partner

Line 20, the amount of 1,273 again represents a correction factor to a likely bookeeping error that has not been found over the years and seems to be increasing. We have kept a very detailed list of how every dollar has been accounted for including a spreadsheet detailing each transfer of money to associates working for us in Africa We also have attempted to increase the accountability of our associates through giving financial reports of every mission taken, as well as getting photos when able. However, photos in certain areas have proven to be dangerous and expensive as our men will get arrested for taking them and this requires us to bail them out of jail. We are working on the best approach to getting permission a priori to avoid conflicts with the gendarme.
