Funds raised via TSF to fund scholarships and school expenses are administered and delivered to the students' schools by the NGO partners. TSF continues to develop and operate its person-to-person funding website (www.theschoolfund.org) where students' profiles and needs are featured. The online platform allows donors to view student profiles, enables students to communicate with donors via online journals, and supports a transparent payment process in which receipts from the student's school or the NGO partner are viewable on the website.
