Innovators Robotics, Inc. is a nonprofit organization started in 2009 to provide STEM opportunities in the Dayton area. The organization is run by a group of volunteers dedicated to inspiring students to pursue STEM related careers. We are a community based organization that is not affiliated with any school, so we accept students from anywhere in the greater Dayton, Ohio area.

Innovators Robotics is associated with FIRST (For Inspiration and Recognition of Science and Technology) Robotics for students of different age groups. Innovators has teams in: FIRST Robotics Competitions (Grades 9-12) and FIRST Tech Challenge (Grades 7-12).

The primary purpose of our organization is to provide STEM exploration and leadership opportunities for students as well as providing volunteer services for community education outreach projects in the Dayton and surrounding areas.

Students learn by working alongside adult mentors who volunteer to teach students the skills that mentors use in their careers.

The teams generally spend about four months out of the year building their robots and attending competitions. The other eight months are dedicated to education outreach programs designed to encourage STEM interest and create more STEM programs throughout the Dayton, Ohio area.

Outreach opportunities include: STEM classes at the Kroc Center in Dayton, Ohio, assist with rookie FIRST Lego League Camp, talk with families about STEM at the National Museum of the United States Air Force. The teams mentor and support FLL, FTC and FRC teams.

In 2020, the eighth student from the organization was awarded a Dean's List Regional Finalist award. The highest student award in the FIRST Robotics.

Overall, Innovators Robotics helps students develop new STEM and leadership skills by solving fun challenges through exploration, experiential learning and teamwork and preparing students for college or workforce development.

For 2020 and COVID-19, the season was cancelled in Mid-March. Later in the year, meetings were either virtual or limited in size for social distancing. Education outreach opportunities that the teams support were cancelled. Hopefully, later in 2021, teams can resume outreach opportunities.
