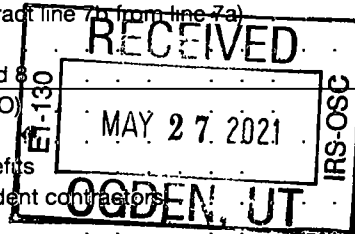

We typically hold a reserve of one month's expenses plus a \$1000 emergency reserve. The rest is given away. We are 100% volunteer staffed. In 2020, we were closed for several stretches because of the pandemic, for the protection of our older adult volunteers and customers. We also lost three key founding volunteers, two who were also board members, to cancer. It was a very disappointing year to not be able to open, sell, and give money to the organizations in the county who so desperately needed help so they could help others.
