OHGM primary service in Ecuador is hosting teams from the United States. Each year OHGM and our missionary, Katty Aguirre, host between 10 and 15 teams. Due to COVID, only 3 teams visited in 2020. Therefore, the organization shifted focus to deliver as much as possible the services typically provided by teams. The local Ecuadorian missionary and her assistants provided medical assistance, drugs, financial support, boots, and many, many food baskets to needy families. While the focus is on the Quichua people, 2020 saw the organization support people all across Ecuador. Much of 2020 expenditures went directly to serving the people of Ecuador while sharing the gospel.

Form 990, Part III, Line 4b:

OHGM's foreign missionary and independent contractor in Ecuador, Katty Aguirre, also conducts direct community support outside the work done individually by US based teams. In this work, Katty arranges and provides leadership training and education for churches, bibles and education materials, provides church facilities support on special projects roof, etc., and operates soup kitchens. She has also begun operating a pregnancy center and holds large community gatherings and celebrations for Christmas and other religious holidays. These programs are directly reimbursed by OHGM.

Form 990, Part III, Line 4c:

OHGM missionary, Katty Aguirre, maintains a large physical dwelling in Ecuador to support missions operations. Operations include hosting events and teams from the United States. The large missions center is designed to host large groups. While the number of visiting teams and face-to-face meetings were down significantly in 2020, the mission organization tackled a number of overdue maintenance projects. Many of these projects were costly, but will position the ministry to operate smoothly and efficiently as the impact of COVID lessens.

At the annual board meeting, the foreign missionary, Katerina Aguirre, attends in person to share the performance against the prior budget and highlights a look forward budget for the coming year. The board votes to fund or not fund, then tracks performance against the missionary plan for work in Ecuador. If expenses arise that are higher than budget, the missionary requests funding from the board and the board must vote for any additional funding more than \$2,500 over the original planned budget. All transactions are cash, there is no property owned by OHGM, only by the independent contracting missionary in Ecuador. All accounting is using cash method only. Typically, all funds are directed through the independent contracting missionary for use by her in achieving her goals and objectives in Ecuador. OHGM has aligned her goals and the goals of OHGM mission. Katty Aguirre oversees an unincorporated Ecuadorian mission organization and the board directs all funding through Katty as the single recipient, representing both her organization and her as an individual.
