Part III - Primary exempt purpose: The mission of Alliance for Haiti's Children is to partner with rural communities in Haiti to provide a quality education for their children by building education capacity throughout local schools. Our replicable model improves education through seven integrated programs: an academic enrichment program comprised of an interscholastic academic competition and a summer enrichment camp; student sponsorships for students attending 15 local primary and secondary schools; school support through building improvements and academic resources; teacher professional development; assistance for the community vocational school, which provides training to enhance student job placement opportunities; all supported by a community library and computer lab. The program operates in La Vallee Jacmel, Haiti.

Line 28: In 2020, The Alliance focused primarily on Community Support to assist the LaVallee community in responding to the Covid pandemic. The Alliance provided emergency food relief to 104 students' families (548 people) who had lost their sources of income as a result of the pandemic lockdowns. Distribution of gardening tools and seeds also helped families and schools grow their own food. Alliance camp counselors sewed and distributed hundreds of masks to local schools and students and educated families on sanitary measures to prevent the spread of Covid. In addition, the Alliance partnered with community leaders to build an outdoor sport court with bleachers for community

sporting events. This partnership group also renovated the outdoor market in the center of town, adding solar lighting, a playground and benches and greenery for outdoor meetings and study sessions. The Alliance continued support in 2020 for the community library and computer lab, the only facility providing these services in the region. Solar panels provided by the Alliance power the building and computers allowing consistent lighting and computer power for nighttime meetings and study sessions. The library facility allows the community of more than 40,000 people free access to computer training and the world of online learning. In 2020, more than 500 students and community members visited the library each month. The Alliance paid the salary of one librarian, who assisted students with computer training, research, typing and copying services.

Line 29. In 2020, the Student Sponsorship program provided tuition support for 265 students attending 16 primary and secondary schools and 13 post-secondary schools. These sponsorships also provided uniforms, books and supplies as needed.

Line 30. In 2020, the Alliance supported 15 schools in LaVallee through the after-school interscholastic competition, Genie Interscolaire. Approximately 2500 students benefited from this semester-long program. The academic competition provided weekly quiz contests based on the Haitian national curriculum. Students competed for placement on their school teams, which then competed against each other. The competition has had demonstrable results, raising passing rates on national exams by 5 to 30 percent. The Alliance also provided classroom materials, art supplies and athletic equipment to 15 local schools. In addition, the Alliance supported teacher salaries through stipends for teachers at the neediest schools in the area.
