In order to assist the Organization in identifying potential Covered Transactions, each Covered Person who currently serves as an officer, director or key employee annually shall complete and sign a Conflict of Interest Questionnaire and Declaration ("Declaration") provided by the Organization and shall update such Declaration as necessary to reflect changes during the course of the year. Completed Declarations shall be available for inspection by the Board of Directors and the officers of the Organization and by such other persons as the Executive Director may deem appropriate. This Policy shall be administered by the Board with assistance from the Chief Operating Officer. If the Chief Operating Officer is party to a potential or actual Covered Transaction, the duties of the Chief Operating Officer under this Policy shall be performed by another officer. The Chief Operating Officer shall provide a copy of this Policy to each current Covered Person and to all new Covered Persons upon undertaking the duties of such office.</p>
