Grants paid of \$125,510 break down into three categories. Hardship grants which are awarded to families that are suffering from financial hardship due to breast cancer treatment that totaled \$119,560. Grant sizes are determined based on the financial needs and set based on actual expenses being incurred by the family. Grants ranged from \$500 to \$3,000. A total of one hundred and forty six grants were awarded in 2020. The second category is a yearly scholarship that is awarded to a student that has a parent or guardian affected by breast cancer. Each year a new student is awarded a 4 year renewable \$500 scholarship. Each year a total of \$2,000 in scholarship money is awarded, 1 new scholarships and 3 renewals from previous years. The third category is Well Wishes, which are small packages of flowers, edible arrangements, or notes of encouragement with a spa/massage treatment that are given to women that might not necessarily have a financial hardship from their illness. The well wish packages range in cost from \$50 - \$150, twenty-six well wish packages were awarded in 2020 for a total of \$3,950.

Other expenses of \$36,576 are all fundraising expenses from our main fund raising event a charity ball and silent auction that takes place in the winter in Q1. Of which \$23,352 is the cost of the venue and dinner for the 500 guests. The remainder of the expenses are silent auction items, decorations, and miscellaneous items.

Total liabilities of \$2,500 are from awarded scholarships. Each year a scholarship is awarded and it is a renewable four year scholarship. The pending payments are accounted for as liabilities.
