Form 990, Part III, Line 4a:

In 2020, 140 youth and young adults (13-24 years old) participated in the Pinellas SHARP (Substance Abuse and HIV Awareness and Responsibility) program. We tested/counseled 74 youth for HIV and 56 youth for Hepatitis C. We had projected higher testing and program enrollment numbers but due to COVID-19, the facilities we work with were either shut down or not open to practitioners and our office was also briefly closed. We conducted our SIS program in person and virtually at 10 different locations and conducted testing at 6 locations. We participated in 8 outreach events and community health fairs and 9 virtual events which reached approximately 300 individuals. We sent out social media messages (instagram, twitter and facebook) on community events and various health/prevention topics (HIV, alcohol, opioids, substance abuse prevention, stigma, mental health, condom usage, smoking cessation).The yearly social media reach is estimated to be 8,921 (according to social media analytics).
