Grants made in 2020 totaled \$112,909. The grants were made to the Heather Chimoga Orphan Center in Murewa, Zimbabwe. Grants are generally made via wire transfer to the local bank account of HCOC in Zimbabwe. ZMP has influence over how the funds are distributed but it does not have signing authority on the local bank account. Thus the grants are not made directly by ZMP to vendors, workers, schools etc.

Part 1, Line 16

The "other" expenses in 2020 of \$6045 were associated with two athletic events (biking and golfing) which raise money for ZMP. These expenses were lower in 2020 than in previous years since the events became virtual due to Covid - 19.

Part 1, Line 26

The amount on this line reflects donations made in 2020 for a designated purpose (such as school fees) but not expended in that year. In order to keep track of the commitment, while using cash accounting, we account for it as a liability to be expended the next year as promised.
