4a (Code: Russia) (Expenses \$ 65,340 including grants of \$ 32,359) (Revenue \$ 30,085)

One trip was undertaken to Kamchatka and Vladivostok. We continued to provide support for the orphan program for those that are now adults. Provided seminars on life skills for them. Guest speakers for the event were one couple from Belarus who provided group and one-on-one teaching for families. Brought adults from Alaska and did both seminars for orphan kids, prisoners, foster families, and the general public. Support was given to our main missionary family there. Provided funding for churches and our youth center in Vladivostok. Conducted three women's seminars in both cities.

4b (Code: Kenya) (Expenses \$ 42,359 including grants of \$ 34,059) (Revenue \$ 28,350)

REM funds to Kenya are used to sponsor students and pay for fees of those who are attending high schools and colleges. Funds are also used to provide health care in institutions such as the CURE hospital for children who are unable to care for themselves or who have no family support. Work of DTL Bible Center continues with the addition of clean water tanks and well. Separate clean bathrooms were erected and small housing for visiting students. Vacation Bible Schools were expanded along with university outreaches.

4c (Code: Nuteki/Bel) (Expenses \$ 4,467 including grants of \$ 0) (Revenue \$ 4,300)

One trip was undertaken to see our ministry funds in action. Met with large group of the 6pm team and discussed their strategies. Funds were used for general support of the Nuteki band, their equipment and five families. Nuteki is an evangelical outreach rock band to Russian speaking countries. Support was also given to the youth outreach program called 6pm World Word on the Street is also an active ministry. REM partnered closely with Steiger International on these ministries.
