In recent years, we have built a relationship with Mwangaza Top View Academy, located in Golole, Kenya. Mwangaza provides an exceptional opportunity for impoverished children (many of whom are supported through our orphan care work). In 2020, funds were provided to Mwangaza for them to purchase and install two large water tanks and a system to collect rainwater that enables them to have adequate water at the school for handwashing as well as drinking water. This has been especially important during the current pandemic, as schools needed adequate handwashing facilities in order to reopen per government mandates). Hand of Hope was also able to fully fund the construction of a new building to house two classrooms as well as provide large tents to accommodate temporary outside classrooms, which was needed in order to meet social distancing guidelines set by the government.
