THE FOUNDATION RESPONDED BY RAISING FUNDS FOR FIREFIGHTERS TO GET MORE SAFETY EQUIPMENT TO PROTECT THEM FROM VIRUS, BLOOD AND CHEMICALS; PLUS SANITATION EQUIPMENT AND SUPPLIES TO KEEP THEIR MEDICAL EQUIPMENT, AMBULANCES, AND FIRE STATIONS CLEAN. EVEN WORSE THAN A FIREFIGHTER BECOMING ILL, WOULD BE THE VIRUS SPREADING FROM PATIENT TO PATIENT.

ALL DEPARTMENTS MUST BE ABLE TO WORK TOGETHER IN A HIGHLY COORDINATED MANNER DURING THESE FIRES, WE CANNOT AFFORD TO HAVE A WEAK LINK.
