

Where necessary we rent meeting rooms and facilities for these activities. Costs are usually recovered through contributions and book sales. Where some training programs require providing supplies we may charge a minimal fee to cover these costs. The public access programs are often attended by community groups, Scout groups and other not-for-profit organizations. Public programs have included outdoor survival, edible plants, home emergency preparedness, disaster first aid, outdoor safety, fire starting, and shelter building water purification, winter survival, alternative energy, survival gardening, and child safety.

The organization publishes American Survival newsletter for members. This publication contains timely survival information and news about survival education activities. The AmericanSurvivor.org website includes many timely survival and preparedness articles for free. Members can download all of these issues of the newsletter and other special publications. We also rent tables or booths at survival and preparedness expositions. At these, we distribute free survival information and sell survival and preparedness books at prices significantly below retail in order to get information to the public. We also help organize and support smaller affiliated preparedness groups through providing publicity, references, and instructors'.
