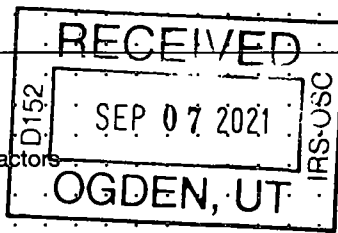

In December 2019 the organization purchased a mobile unit for \$41,000, including delivery cost. The organization also made a \$3,000 down payment for custom wrapping of the unit. In March 2020 all of the improvements were completed and the mobile unit was placed in service. The asset was fully depreciated by electing Sec 179 depreciation for the year ended December 2020, leaving the balance of line 24, other assets zero.
