Those which perform the best on these criteria are named Top or Standout charities and we collect donations on their behalf. Top Charities are reviewed each year and Standouts reviewed every 2 years, to ensure that they used our donors' funds well. If, upon review, we determine a supported charity no longer deserves our recommendation, we phase out collecting donations on their behalf. Research Fund grants: Applications are evaluated based on (i) the relevance of the proposal to animal advocacy, (ii) the strength of the evidence that the study design is likely to achieve, and (iii) the likelihood of success.
