Program 1: Connecting Cultures Outreach-Hosting Program to connect participants (primarily ethnic Korean) with Alaska Natives for the purpose of spreading the Gospel of Jesus Christ through shared cultures by doing ethnic relavant evangelism, service projects, and children's ministries. Due to the effect COVID-19, this program was substantially reduced in scope, with only one outreach team of 12 people ministering with 60 Alaska Native children and adults in Ketchikan.

Program 2: Discipleship Training Seminar Program to make available basic discipleship training to participants in the local church and community who want to become better equipped for sharing the Gosple of Jesus Christ and living more effective lives in the home, work place, and on outreach events. Using curriculum, videos, and qualified presenters to empower participants to impact thier sphere of influence. Due to COVID-19 this program was not available in 2020.

Program 3: Alaska/Mongolia Bridge Program to connect Mongolian Christians with Alaska Native people in Southeast Alaska One YWAM Ketchikan staff family made preparations to move to Mongolia full time. Their departure from Ketchikan and arrival in Korea coinciding with the advent of COVID-19 which resulted in Mongolia closing it's borders and stranding the YWAM Ketchikan staff in Korea. Nevertheless, the program was adapted to remotely facilitate the availability of much needed relief resulting in 300 Mongolian famlies living in dire circumstances being served, and a church being planted by Mongolian Nationals.
