This year funds were provided for additional materials for the media collection, licenses to show movies at the Library, a Zoo pass to the Milwaukee County Zoo made available to Library patrons at no charge, Summer Reading Program materials for Adults, Youth and Young Adults, Materials for the Memory Cafe and the Wisconsin Science Festival. Planters and seasonal arrangements were also purchased for the exterior of the Library. All of these grants were for items requested by the Library Director and whose use fulfill the Library's stated purpose.
