In September 2020 the organization began to slowly transition back to 25% in office appointments; however, after three weeks we saw a surge in Covid19 cases and once again closed our doors to the public and returned to 100% telehealth services. In November 2020 we sent all of our employees home to work to slow the spread of Covid with the exception of our receptionists. This continued until January 16, 2021. Sioux Trails is seeing a small portion of clients in office with hopes of returning to more in office appointments very shortly. Sioux Trails received a PPP loan & CARES funding. The PPP loan was used exclusively for payroll costs which allowed 100% forgiveness through the SBA. The CARES funding was received and the organization will be using those funds towards the applicable expenses.
