We then give an opportunity for members to view all issues brought up statewide and indicate which issues are a priority. In March of each year, we send out a survey asking members opinions on several issues that were the most important to the membership. Our board of directors uses that information to come up with policy for the company. We presented our policy at the company virtual annual meeting in August. A delegate from the company takes the suggested issues and speaks for the company at the state conference. The company donated to the local county rescue team of oxygen tanks as part of a share grant from the state.
