Community Investment (Allocations): Occurs each February. After our annual campaign, a group of community volunteers come together to allocate campaign dollars to social service agencies that serve Mahaska County. Local agencies submit grant applications and make presentations outlining the programs they would like funded. In 2020, United Way of Mahaska County funded 14 local agencies. These agencies focus their efforts on addressing education, income, health, and basic needs throughout Mahaska County.

COVID Relief: With the arrival of the pandemic, United Way of Mahaska County began receiving donations designated to COVID Relief efforts. Initially, grants were awarded to three partner agencies for their programs. Upon receipt of a large donation through United Ways of Iowa, United Way began reaching out to local school districts to see what needs they had as they returned to in-person learning. Some of the expenses covered included purchase of facemasks for students and teachers, along with lanyards to be used with them; parking hang-tags to facilitate student drop-off and pick-up; Internet hot spots for 12 high school students that needed to utilize online learning but did not have internet access in their homes; disinfecting/cleaning solutions for multiple school buildings; and a Social Emotional Learning Program (Can Do U) at Oskaloosa High School to help address student needs in coping with the emotional impact of the pandemic. Funding not expended has been earmarked for use for COVID related needs in 2021 as the pandemic continues.

Form 990, Part III, Line 4c:

Oskaloosa Summer Lunch Program: In 2020, United Way of Mahaska County transitioned from being Fiscal Agent and Sponsor of the Oskaloosa Summer Lunch Program to partnering with the Oskaloosa Community School District (OCSD). OCSD now provides meal planning and preparation and United Way recruits and coordinates volunteers needed for the Program. OCSD also became fiscal agent and expenses reflected here include transfer of funding to the school system. This is a USDA funded summer food service program. Due to COVID, the program transitioned to a Pick-Up service, with 5 days of breakfasts and lunches picked up on Wednesdays over the lunch hour. In Summer 2020, more than 6,500 weekly meal bags (65,000 individual meals) were distributed at 7 locations throughout Oskaloosa and Mahaska County.

Take-Along Food Program: United Way of Mahaska County's Take-Along Weekend Food Program provides bags of meals, snacks and drinks to students who struggle with food insecurity over the weekend. Each Friday during the school year, the program served approximately 95 students at Oskaloosa Elementary School, Oskaloosa Middle School, Eddyville Elementary School and Fremont Elementary School.

Back to School Fair: Each summer United Way of Mahaska County sponsors a school supply drive, collecting school supplies and accepting donations for purchase of backpacks and supplies. Any child or youth (preschool through 12th grade) residing in Mahaska County is eligible to receive a filled backpack through this program. In 2020, a drive-thru Back to School Fair was organized to distribute the backpacks, as well as offer shoes and socks. In-car dental screenings were offered to students that were required to have such screening to meet state health guidelines. Agencies that offer programming for youth were able to submit information about their activities for inclusion in the backpacks. Over 350 backpacks were distributed to families in need. Some of the leftover school supplies were given to local schools to stock school supply closets, which can be utilized by teachers throughout the year. We partnered with Salvation Army, Mahaska YMCA, Soles 4 Souls and the school districts in Mahaska County.
