

THE DIGITAL HARBOR FOUNDATION (DHF) TECH CENTER IS LOCATED IN THE FORMER SOUTH BALTIMORE RECREATION CENTER AND WAS OPENED BY DHF IN JANUARY 2013. THE TECH CENTER PROVIDES OUT-OF-SCHOOL-TIME STEM-RELATED SCIENCE, TECHNOLOGY, ENGINEERING, MATH (STEM) PROGRAMS FOR YOUTH. THE SPACE IS APPROXIMATELY 5,000 SQUARE FEET IN SIZE. PROGRAMS CREATED BY DHF AND RUN AT THE TECH CENTER INCLUDE A SERIES OF SUMMER TECHNOLOGY CAMPS, AFTER SCHOOL TECHNOLOGY EDUCATION PROGRAMS TEACHING WEB OR MOBILE APPLICATION DEVELOPMENT, DIGITAL FABRICATION (INCLUDING 3D PRINTING), AND OTHER RELATED SKILLS. DUE TO COVID-19 THE TECH CENTER PROGRAMS WENT VIRTUAL.
