**Line 10: Amounts Paid \$ 4,907.** Athens PRIDE usually puts on a series of events throughout the year to support the LGBTQ community in Athens, GA. Because the events are in-person (exs. Athens PRIDE Festival and Community Fair, Queer Prom, etc), we were not able to host them because we could not host them and follow CDC COVID guideline. Therefore, this year, we used the funds we had to help those in the Athens Community most affected by COVID-19. We did this by paying out \$4,907 to help members of LGBT low income, Latin X, Seniors, HIV+ persons, and those living with mental illness who were financially impacted by COVID. We distributed the funds by collaborating with five other 501(c)3 organizations: 1) Mutual Aid Athens (<https://www.athensmutualaid.net/>), which helped distribute rent money, 2) Casa de Amistad (<http://athensamistad.com/>), which distributed funds to the Athens underserved LatinX community, 3) Athens Area Community Council on Aging (<https://www.accaging.org/>), which serves senior citizens in Athens, 4) Nuci Space (<https://www.nuci.org/>), which helps the Athens population by providing mental health treatment to those who cannot afford it. 5) Live Forward (<http://www.liveforward.org/>), which provides housing for Athens community members living with HIV.

**Line 16: Other expenses.** This included our Director's and Officers' Insurance and conference registration fees for the UGA Connect Conference (<https://lgbtcenter.uga.edu/connect-conference/>) on February 7, 2021.

**Line 31: Athens PRIDE** donated the money we made from t-shirts and masks to the Athens Anti-discrimination Movement (<https://www.aadmovement.org/>) to support Athens queer people of color.

**Line 35b: Athens PRIDE** did not file Form 990-T because we do not have paid employees and therefore do not pay out retirement benefits. I checked the box because we made a profit from our t-shirt sales that we used to help the community.
