<p>28 General Refugee Assistance: Family Services provides a wide range of refugee assistance such as mentoring to new mothers, transportation to appointments, help with navigating the medical systems, educational services, health insurance, and other community services, job search, application process, and interview support, assistance locating and obtaining housing, home ownership training and assistance purchasing a home and any other assistance clients may need. In 2020 we served 446 clients in our Family Services Department. Immigration Services presents a low-cost way for refugees and asylees to meet their ongoing requirements for immigration documents to be submitted to US Immigration Services. We provide this service through a partnership with Community Legal Center, whose attorneys meet with clients and prepare their documents, then submit applications on behalf of the client. Asha's Refuge assists the attorneys by helping clients organize the information required by attorneys, and by providing Civil Surgeons to perform required exams. These services enable families and individuals to save hundreds of dollars in legal fees and medical exam expenses while meeting their reporting requirement timely and accurately.
