School garden program provides students and school communities with an engaging outdoor learning environment where young people can learn to use tools and practice creative problem solving as the urban land stewards of their school campus. Terra BIRDS also gives logistical and project management support so that school gardens can be long term assets within a school. Educational projects include leading 250 students at 4 schools in the Flagstaff Unified School District and Coconino County Regional Accomodation School District. School gardening enriches students and connects them to the ecosystems that surround them. Students transform themselves while transforming school grounds.
