THE COMMITTEE MEETS ANNUALLY OR AS NEEDED TO REVIEW THE COMPENSATION PROGRAM AND MAKE RECOMMENDATIONS, AS APPROPRIATE. A PERFORMANCE EVALUATION IS CONDUCTED ON AN ANNUAL BASIS AND IS INTENDED TO ENSURE THAT THE COMPENSATION PROGRAM FALLS WITHIN A REASONABLE RANGE OF COMPETITIVE PRACTICES FOR COMPARABLE POSITIONS AMONG SIMILARLY SITUATED ORGANIZATIONS. FOLLOWING THIS REVIEW, COMPENSATION, INCLUDING ANNUAL BASE SALARY PLUS ANY YEAR-END BONUS, IS APPROVED FOR THE PRESIDENT/EXECUTIVE DIRECTOR AND OTHER SELECTED KEY EXECUTIVES, AND OBJECTIVES AND GOALS FOR THE UPCOMING YEAR ARE ESTABLISHED. DURING 2020, THE ORGANIZATION CONTRACTED WITH PHILLIPS OPPENHEIM TO RECRUIT THE INAUGURAL EXECUTIVE DIRECTOR, WHO IS EXPECTED TO BE HIRED IN 2021.
