Part V, Line 4:	The Institute plans to use endowment funds to reduce the amount of current year operating funds that it needs to raise in any given year. To that end, in 2017, the Institute established a permanently restricted endowment fund with a multi-year Alford Challenge Grant totaling \$1.4M. Now that the permanently restricted fund created by the grant has reached the full \$1.4M, the Institute will begin using proceeds from the fund's principal to offset the cost of 90 of the 540 program participants each year. The Institute also held aside matching funds to the grant to create a second fund of \$1.4M that may, in the future, fund an additional 90 program participants annually. Under the Institute's current plan, annual fundraising to raise operating funds may be reduced by the cost of 180 program participants. The coverage of program participant costs by the endowment may grow as the Institute finds other ways to grow the endowment in the future.

Part X, Line 2:	The Institute is exempt from federal and state income tax under section 501(c)(3) of the Internal Revenue Code. The Institute qualifies for the charitable contribution deduction under Section 170(b)(1)(A) and has been classified as an organization that is not a private foundation. Accordingly, no provision for income taxes has been recorded in the financial statements. Tax-exempt organizations could be required to record an obligation for income taxes as the result of a tax position they have historically taken on various tax exposure items including unrelated business income or tax status. Under guidance issued by the Financial Accounting Standards Board (FASB), assets and liabilities are established for uncertain tax positions taken or positions expected to be taken in income tax returns when such positions are judged to not meet the "more-likely-than-not" threshold, based upon the technical merits of the position. Estimated interest and penalties, if applicable, related to uncertain tax positions are included as a component of income tax expense. The Institute has evaluated the position taken on its filed tax returns. The Institute has not taken, nor does it expect to take any uncertain tax positions in any income tax return.
