WRITERS ARE BROUGHT IN TO READ AND/OR LECTURE FOR THE BENEFIT OF BOTH THE GENERAL PUBLIC AND LOCAL SCHOOLCHILDREN. THERE ARE SEVERAL AUTHOR PROGRAMS EACH YEAR, HELD EITHER IN THE PUBLIC SCHOOLS OR IN A NEARBY CONFERENCE FACILITY. PROGRAM PARTICIPANTS PAY FEES TO ATTEND LECTURES, EXCEPT FOR THOSE HELD IN THE PUBLIC SCHOOLS. THE MOST SIGNIFICANT EVENT IS A WORKSHOP HELD IN OCTOBER, WHERE SEVERAL AUTHORS SPEAK AND LEAD WORKSHOPS.
