This group is limited to women who fit the following criteria: 1.) Diagnosed with a breast and or gynecologic cancer. 2.) Completed primary treatment (i.e. surgery, chemo, radiation) 3.) Body Mass Index (BMI) = 30. This program includes custom designed group fitness exercise three-times a week; weekly support groups with fellow EXTRA-TOUGHS to address successes and challenges together and weekly nutrition classes to learn healthy eating habits. In 2020, the EXTRA-TOUGHS Anchorage program had four 12-week cycles with a total of 3 new starts to the program and 48 returning women. Generous grant funding from the State allowed Let Every Woman Know - Alaska to expand the EXTRA-TOUGHS program to the Mat-Su Valley for one year from June 2019 - June 2020. There were two 12-week cohorts in 2020 with a total of 1 new start and 5 returning women.
