WINGED HOPE'S PRIMARY PURPOSE IS TO PROVIDE SUPPORT TO VICTIMS OF CHILD ABUSE, DOMESTIC VIOLENCE AND MENTAL HEALTH ISSUES, INCLUDING SUICIDE AND DOMESTIC VIOLENCE PREVENTION. WE PROVIDE EDUCATIONAL PROGRAMS IN OUR COMMUNITIES AND SCHOOLS IN ARIZONA SPECIFICALLY CREATED USING AGE APPROPRIATE MATERIALS ON ABUSE AND VIOLENCE. IN CONJUNCTION WITH LOCAL GOVERNMENTS/POLICE, WE ALSO ESTABLISH FAMILY ADVOCACY CENTERS AND VICTIM SHELTERS. ALL SERVICES OF WINGED HOPE ARE ACCOMPLISHED BY VOLUNTEERS.

OUR GOAL IS TO TREAT VICTIMS FROM INTERVENTION TO RECOVERY THROUGH ADVOCACY AND HEALING THERAPY. IN ADDITION, OUR EDUCATIONAL OUTREACH IS TO ENCOURAGE SPEAKING FREELY AND OPENLY IN SAFE GROUPS TO FORESTALL ABUSE AND TO PROVIDE SUPPORT BEFORE ANY INCIDENT.

WINGED HOPE'S OUTREACH HAS TOUCHED THOUSANDS OF VICTIMS AND EDUCATED THOUSANDS MORE ON THE ISSUES. IN 2020, AN ADDITIONAL 1,251 VICTIMS WERE SERVED. WE ARE PROUD TO HAVE BEEN RECOGNIZED BY THE ARIZONA ATTORNEY GENERAL FOR SERVING ARIZONA STATE VICTIMS (2018) AND WAS SELECTED AS THE BEST NON-PROFIT IN GILBERT, ARIZONA (2020).
